## AN ACT

To repeal section 304.820, RSMo, and to enact in lieu thereof one new section relating to the use of electronic wireless communication devices, with penalty provisions.

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Section 304.820, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 304.822, to read as follows:

**304.822. 1. As used in this section, the following terms mean:**

(1) "Electronic message", a self-contained piece of digital communication that is designed or intended to be transmitted via an electronic wireless communication device, which includes, but is not limited to, electronic mail, a text message, an instant message, or a command or request to access an internet site;

(2) "Electronic wireless communication device", includes, but is not limited to, a cell phone, personal digital assistant, electronic device with mobile data access, laptop computer, pager, broadband personal communication device, electronic game, or portable computing device. An "electronic wireless communication device" shall not include:

(a) A global navigation satellite system receiver used for positioning, emergency notification, or navigation purposes; and

(b) Two-way or citizen band radio services;

(3) "Hands-free electronic wireless communication device", a wireless communication device that has an internal feature or function, or that is equipped with an attachment or addition, regardless of whether permanently part of such wireless communication device, by which a user engages with the device without the use of either

17 hand; provided, however, this definition shall not preclude the use of either hand merely  
18 to activate, deactivate, or initiate a function of the device;

19 (4) "Highway", any public thoroughfare for vehicles, including state roads, county  
20 roads, public streets, avenues, boulevards, parkways, or alleys in any municipality;

21 (5) "Operating", physically driving or operating a motor vehicle on a highway,  
22 including operation while temporarily stationary because of traffic, a traffic light or stop  
23 sign, or otherwise. A person is not "operating" a motor vehicle for purposes of this section  
24 when the vehicle has pulled over to the side of, or off, a highway and has stopped in a  
25 location where it can safely remain stationary.

26 2. Except as otherwise provided in this section, no person shall operate a  
27 noncommercial motor vehicle, as such term is defined under section 302.700, upon the  
28 highways of this state while using any hand-held electronic wireless communication device.  
29 Prohibited uses shall include, but not be limited to, reading, composing, viewing, or posting  
30 any electronic message; initiating, receiving, or conducting a conversation; or manually  
31 typing data into any electronic wireless communication device.

32 3. Except as otherwise provided in this section, no person shall operate a  
33 commercial motor vehicle, as that term is defined under section 302.700, while using any  
34 wireless communication device for any purpose including, but not limited to, reading,  
35 composing, viewing, or posting any electronic message; initiating, receiving, or conducting  
36 a conversation; or manually typing data into any hand-held electronic wireless  
37 communication device.

38 4. The provisions of subsections 2 to 3 of this section shall not apply to a person  
39 operating:

40 (1) An authorized emergency vehicle as defined under section 304.022;

41 (2) A motor vehicle that is responding to another motor vehicle's request for  
42 roadside assistance upon the highways of this state when such response is conducted in the  
43 course and scope of a commercial activity; or

44 (3) A motor vehicle while using a hand-held electronic wireless communication  
45 device to:

46 (a) Contact emergency services; or

47 (b) Relay information between a transit or for-hire motor vehicle operator and that  
48 operator's dispatcher when the device is affixed to the motor vehicle.

49 5. Nothing contained in subsection 2 of this section shall be construed or  
50 interpreted to prohibit a person operating a noncommercial motor vehicle, as such term  
51 is defined under section 302.700, on the highways of this state from using a hands-free  
52 electronic wireless communication device when the operator is not holding the hands-free

53 **electronic wireless communication device in the operator's hand or hands, except the**  
 54 **operator shall not have his or her attention diverted from the lawful operation of the**  
 55 **noncommercial motor vehicle. The provisions of subsection 2 of this section shall not**  
 56 **prohibit the use of either hand merely to activate, deactivate, or initiate a function of a**  
 57 **hands-free electronic wireless communication device while operating a noncommercial**  
 58 **motor vehicle.**

59 **6. A violation of this section shall be deemed an infraction punishable by a fifty-**  
 60 **dollar fine. A violation of this section while operating a motor vehicle in a work zone, as**  
 61 **defined under section 304.580; when highway workers, as defined under section 304.580,**  
 62 **are present; or in areas designated as a school zone that are visibly marked by traffic**  
 63 **control devices shall be deemed an infraction punishable by a one-hundred-dollar fine. A**  
 64 **violation of subsection 2 of this section shall not be deemed a moving violation for purposes**  
 65 **of point assessment under section 302.302; however, a violation of subsection 3 of this**  
 66 **section shall be deemed a serious traffic violation, as defined under 302.700, for purposes**  
 67 **of commercial driver's license disqualification under section 302.755.**

68 **7. The provisions of this section shall not preclude the adoption of any law,**  
 69 **ordinance, order, rule, or regulation not in conflict with this section, or at least as strict as**  
 70 **this section, by any county, municipality, or other political subdivision.**

71 **8. Notwithstanding any provision in this section to the contrary, no person less than**  
 72 **eighteen years of age, or with an instruction permit or intermediate license regardless of**  
 73 **age, shall use a hand-held electronic wireless communication device or a hands-free**  
 74 **electronic wireless communication device while operating a motor vehicle on the highways**  
 75 **of this state except to contact emergency services.**
